<b>Important Questions</b>	Answers	Why this Matters
What is the overall deductible?	\$7,500 person / \$15,000 family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes, the <u>deductible</u> doesn't apply to <u>preventive care</u> , services subject to flat dollar co-pays, limited virtual care services, prescription generic drugs or pediatric vision services.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	\$9,400 person / \$18,800 family	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. What is not included in the out-of-pocket limit?
