Important Questions	Answers	Why this Matters
<b>What is the overall deductible?</b>	\$9,100 person / \$18,200 family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes, the <u>deductible</u> doesn't apply to <u>preventive care</u> , office visits, retail health clinic visits, urgent care center visits, substance use disorder outpatient visits, prescription generic drugs or pediatric vision services.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without cost-sharing and before you meet your <u>deductible</u> . <b>Are there other deductibles for specific services?</b>	No.	You don't have to meet <u>deductibles</u> for specific services.
<b>What is the out-of-pocket limit for this plan?</b>	\$9,100 person / \$18,200 family	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
<b>What is not included in the out-of-pocket limit?</b>	Premiums, balance-billed charges, health care this <u>plan</u> doesn't cover, additional costs you may pay if you choose to receive a brand name drug when an equivalent generic drug is available or a non-preferred drug when a preferred drug is available, services that exceed an annual day/visit limit, and any <u>co-pays</u> and <u>co-insurance</u> you pay for any non-essential health benefits.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
<b>Will you pay less if you use a network provider?</b>	Yes. See PriorityHealth.com or call 1-800-528-8762 for a list of <u>participating providers</u> .	This <u>plan</u> uses a <u>provider network</u> . You will pay less if you use a <u>provider</u> in the <u>plan's network</u> . You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays ( <u>balance billing</u> ). Be aware your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.
<b>Do I need a referral to see a specialist?</b>	Yes.	This <u>plan</u> will pay some or all of the costs to see a <u>specialist</u> for covered services but only if you have <u>referral</u> before you see a <u>specialist</u> .

# MyPriority HMO<sup>SM</sup> — Zero Cost Share for Limited Services

If you are an American Indian or a Native Alaskan, and the Marketplace determines you meet certain eligibility requirements, you do not have to pay your deductible, co-pays or co-insurance for a limited number of services.

Important information	Answers
<b>What is the zero cost share provision?</b>	<p>The zero cost share provision exempts certain items or services from the deductible, co-pays or co-insurance of your plan when they are provided:</p> <ul style="list-style-type: none"> <li>• directly to you by the Indian Health Service, an Indian Tribe, Tribal Organization, or Urban Indian Organization; or</li> <li>• through referral under contract health services.</li> </ul>
<b>How does zero cost share work?</b>	<ul style="list-style-type: none"> <li>• If the Provider (Indian Health Service, Indian Tribe, Tribal Organization, Urban Indian Organization, or the provider you see through referral under contract health services) is a Participating Provider, there is no charge.</li> <li>• If the Provider (Indian Health Service, Indian Tribe, Tribal Organization, Urban Indian Organization, or the provider you see through referral under contract health services) is a Non-Participating Provider, there is no charge up to a Reasonable and Customary amount.</li> </ul>
<b>What are the limitations?</b>	<ul style="list-style-type: none"> <li>• Services must be Medically/Clinically necessary</li> <li>• Services will count toward the same day and/or visit limitations as the services not covered under the zero cost share provision. See your plan documents for additional information.</li> </ul>
<b>What is Reasonable and Customary?</b>	<p><b>Reasonable and Customary</b> is the charge for covered services which is the lower of: (a) the Providers usual charge for any covered service; or (b) the charge we determine to be the prevailing charge level for any covered service. See your plan documents for additional information.</p>
