Important Questions	Answers	Why this Matters
What is the overall <u>deductible</u>?	\$2,000 person / \$4,000 family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes, the <u>deductible</u> doesn't apply to <u>preventive care</u> , flat dollar co-pays, limited virtual care services, or pediatric vision services.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without cost-sharing and before you meet your <u>deductible</u> . Are there other <u>deductibles</u> for specific services?	No.	You don't have to meet <u>deductibles</u> for specific services.
What is the <u>out-of-pocket limit</u> for this <u>plan</u>?	\$8,700 person / \$17,400 family	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out-of-pocket limit</u>?	<u>Premiums</u> , <u>balance-billed</u> charges, health care this <u>plan</u> doesn't cover, additional costs you may pay if you choose to receive a brand name drug when an equivalent generic drug is available or a non-preferred drug when a preferred drug is available, services that exceed an annual day/visit limit, and any <u>co-pays</u> and <u>co-insurance</u> you pay for any non-essential health benefits.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a <u>network provider</u>?	Yes. You will receive care within the Trinity Health East Network of doctors and hospitals located around Oakland, Macomb, Wayne, Washtenaw and Livingston counties. See PriorityHealth.com or call 1-800-528-8762 for a list of <u>participating providers</u> .	This <u>plan</u> uses a <u>provider network</u> . You will pay less if you use a <u>provider</u> in the <u>plan's network</u> . You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's charge</u> and what your <u>plan</u> pays (<u>balance billing</u>). Be aware your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.
Do I need a referral to see a <u>specialist</u>?	No.	You can see an in-network <u>specialist</u> you choose without a <u>referral</u> .

MyPriority HMOSM — Zero Cost Share for Limited Services

If you are an American Indian or a Native Alaskan, and the Marketplace determines you meet certain eligibility requirements, you do not have to pay your deductible, co-pays or co-insurance for a limited number of services.

Important information	Answers
What is the zero cost share provision?	<p>The zero cost share provision exempts certain items or services from the deductible, co-pays or co-insurance of your plan when they are provided:</p> <ul style="list-style-type: none"> • directly to you by the Indian Health Service, an Indian Tribe, Tribal Organization, or Urban Indian Organization; or • through referral under contract health services.
How does zero cost share work?	<ul style="list-style-type: none"> • If the Provider (Indian Health Service, Indian Tribe, Tribal Organization, Urban Indian Organization, or the provider you see through referral under contract health services) is a Participating Provider, there is no charge. • If the Provider (Indian Health Service, Indian Tribe, Tribal Organization, Urban Indian Organization, or the provider you see through referral under contract health services) is a Non-Participating Provider, there is no charge up to a Reasonable and Customary amount.
What are the limitations?	<ul style="list-style-type: none"> • Services must be Medically/Clinically necessary • Services will count toward the same day and/or visit limitations as the services not covered under the zero cost share provision. See your plan documents for additional information.
What is Reasonable and Customary?	<p>Reasonable and Customary is the charge for covered services which is the lower of: (a) the Providers usual charge for any covered service; or (b) the charge we determine to be the prevailing charge level for any covered service. See your plan documents for additional information.</p>
