

# CATEGORY III CURRENT PROCEDURAL TERMINOLOGY (CPT®) CODES

#### I. OVERVIEW

This Medical Policy addresses Current Procedural Terminology (CPT®) Category III codes, developed by the American Medical Association (AMA), defined as a set of temporary ("T") codes that allow data collection for emerging technologies, services, procedures, and service paradigms. These codes are intended to be used for data collection to substantiate widespread usage or to provide documentation for the Food and Drug Administration (FDA) approval process. Unlike Category I CPT® codes, the procedures and services described by Category III CPT® codes do not necessitate FDA approval and therefore have been placed in a separate section of the CPT book. Per the AMA, "the inclusion of a service or procedure in this section does not constitute a finding of support, or lack thereof, with regard to clinical efficacy, safety, applicability to clinical practice, or payer coverage." The Category III CPT® Code description does not establish a service or procedure as safe, effective or applicable to the clinical practice of medicine.

#### II. POLICY/CRITERIA

Because of the specific purpose CPT Category III codes serve, unless there is a Priority Health Medical Policy that specifically addresses coverage for a particular Category III code, the item, service or procedure represented by any Category III code is considered experimental, investigational or unproven.

#### III. MEDICAL NECESSITY REVIEW

Prior authorization for certain drug, services, and procedures may or may not be required. In cases where prior authorization is required, providers will submit a request demonstrating that a drug, service, or procedure is medically necessary. Current Procedural Terminology (CPT®) Category III codes are a set of temporary codes, developed by the American Medical Association (AMA), that allow data collection for emerging technologies, services, procedures, and service paradigms. These codes are intended to be used for data collection to substantiate widespread usage or to provide documentation for the Food and Drug Administration (FDA) approval process. Unlike Category I CPT® codes, the procedures and services described by Category III CPT® codes do not necessitate FDA approval and therefore have been placed in a separate section of the CPT book. Per the AMA, "the inclusion of a service or procedure in this section does not constitute a finding of support, or lack thereof, with regard to clinical efficacy, safety, applicability to clinical practice, or payer coverage." The Category III CPT® Code description does not establish a service or procedure as safe, effective or applicable to the clinical practice of medicine.

The CPT Category III codes may not conform to one or more of the following CPT Category I code requirements:



### Category III Current Procedural Terminology (CPT®) Codes

- All devices and drugs necessary for performance of the procedure or service have received FDA clearance or approval when such is required for performance of the procedure or service.
- The procedure or service is performed by many physicians or other qualified health care professionals across the United States.
- The procedure or service is performed with frequency consistent with the intended clinical use (ie, a service for a common condition should have high volume, whereas a service commonly performed for a rare condition may have low volume).
- The procedure or service is consistent with current medical practice.
- The clinical efficacy of the procedure or service is documented in literature that meets the requirements set forth in the CPT code change

Category III codes are not developed as a result of Panel review of an incomplete proposal, the need for more information, or a lack of CPT Advisory Committee support of a code-change application.

CPT Category III codes are not referred to the AMA-Specialty RVS Update Committee (RUC) for valuation because no relative value units (RVUs) are assigned to these codes. Payments for these services or procedures are based on the policies of payers and not on a yearly fee schedule.

Because of the specific purpose CPT Category III codes serve, the item, service or procedure represented by these codes are generally considered experimental, investigational or unproven, unless there is a Priority Health Medical Policy that specifically addresses coverage for a particular Category III code (see table below).
