Healthy Michigan Plan: HRA completion

Identified measure	Priority Health credentialed participating primary care providers (PCP) and mid-level providers, billing under the credentialed participating supervising physician, are eligible for an incentive for proper completion and submission of the annual health risk assessment (HRA).							
	Incentive for annual HRA completion Priority Health will pay an incentive to Priority Health participating credentialed providers only when the provider (physician or mid-level PCP) completes an annual HRA form properly and timely. To receive the incentive, the provider must:							
	<ul style="list-style-type: none">• Conduct a visit with the Healthy Michigan Plan member within the measurement year.• Complete Healthy Michigan HRA with member during visit.• Submit completed HRA form via submission options listed below, within 30 days of the end of the quarterly payout period it was completed in. Credit will be applied to the member's PCP on the date of the corresponding payout period.							
	Completed HRA form submitted by a mid-level provider (billing under the member's credentialed participating Primary Care Physician) is eligible for an incentive for proper completion and submission. The mid-level provider completing the HRA doesn't need to be credentialed.

The incentive for the annual health risk assessment (HRA) is paid out quarterly and must be submitted no later than 30 days after the end of the quarter it was completed in.</p> <p>To be considered for the incentive, the HRA must be signed and include the provider attestation information. Handwritten forms must be legible.
